I am familiar with and will comply with all rules and regulations for safe operation of the standup paddle board and/or kayaks.

I UNDERSTAND THAT BY SIGING THIS DOCUMENT, I AM WAIVING VALUABLE LEAGAL RIGHTS, INCLUDING ANY AND ALL RIGHTS I MAY HAVE AGAINST THE RELEASEES, THE OPERATOR NAMED ABOVE, OR THEIR EMPLOYEES, AGENTS, SERVANTS OR ASSIGNS AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE AND INDEMNITY TO THE GREATEST EXTENT ALLOWED BY LAW.
